

- 6. The application must be completed in English. Supporting documents must also be in English. Where the original documents are not in English, please provide a certified English translation of

- 5. Please note that the signatory parties may be copied in correspondence relating to this application.
- 10. Licence-related applications Autominally take around 3 to 16 weeks to process. Applications that are incomplete, complex or submitted during the peak period from January to March may require more time to process.
- 11. If the application is approved, the applicant law practice will be required to register with the Accounting and Corporate Regulatory Authority ("ACRA") if it is a Singapore Law Practice, Foreign Law Practice, Joint Law Venture or Qualifying Foreign Law Practice, and pay the applicable fee specified in the First Schedule of the Legisl Profession (Law Practice Entities) Rules, before it can commence operations in Singapore.













